Introduction

The Sri Lanka-Russia Business Council was inaugurated on 09th August 2001, on the initiative of the then Russian Ambassador in Sri Lanka, Mr. Mikhail A. Konarovskiy and then Chairman of the Ceylon Chamber of Commerce, Mr. Chandra Jayaratne with a primary objective to function as a promoter and facilitator of bilateral trade, investments and tourism between Sri Lanka and the Russian Federation, particularly to promote exports to Russia.

The membership of the Council was 66 as at 31st March 2016

Objectives

- To promote trade, tourism and other services between Sri Lanka and Russia and in particular to promote exports from Sri Lanka to Russia.
- To encourage Russian investment and joint business ventures in Sri Lanka between Russian and Sri Lankan investors.
- To exchange information on trade and investment with the appropriate bodies in Russia.
- To conduct joint meetings with Russian business organizations in Sri Lanka and in Russia.
- To serve as a recognized representative of business sector interests in Sri Lanka in matters concerning business relationships with Russia.
- To promote Sri Lankan participation in trade fairs in Russia.
- To co-operate with the Government of Sri Lanka in the pursuit of the above objectives.
- To establish links with the Chambers of Commerce in Russia to cooperate with each other in the pursuit of each other's objectives.
- To undertake all matters that is incidental or conducive to attaining the above objectives.










Bilateral discussion with Vice President Mr. Vladimir Padalko

Business Delegation to Moscow March 2017

A trade and investment promotion mission to Moscow was organized by the Sri Lanka -Russia Business Council of the Ceylon Chamber of Commerce together with the Sri Lankan Embassy in the Russian Federation, and a 25 member delegation visited Moscow from 22nd to 24th March 2017.

The mission was led by President of the Sri Lanka- Russia Business Council, Mr. Isuru Samarasinghe, Managing Director of Unitrades (Pvt) Ltd, a member of the Bartleet group of companies. This mission was organized in conjunction with the official visit of His Excellency Maithripala Sirisena, President of the Democratic Socialist Republic of Sri Lanka, to the Russian Federation on the invitation of His Excellency Vladimir Putin, the President of the Russian Federation which coincided with 60 years of diplomatic ties between Sri Lanka and Russia.

During the visit of the delegation, the Chamber of Commerce & Industry of the Russian Federation organized a business forum and one-to-one business meetings, thus giving an opportunity to the members of the delegation to meet representatives of Russian companies.

The information about Sri Lanka and its current economic situation was presented by Mr. Upul Jayasuriya, Chairman of Board of Investment in Sri Lanka. Bilateral relations were enriched by strengthening the trade ties, sourcing suitable business partners for trade, investments, joint ventures, technology transfer and services and also assisting in expanding existing business contacts of the participants.







